Sub: Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MS(Orthopaedics) qualification against increased intake from 03 to 04 seats and renewal of recognition for 02 seats in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore.

Sir/ Madam,

I am to state that the General Body of this council at its meeting held on 22/11/2016 considered the Council Assessor's report (11.07.2016) on the standard of examination and other teaching facilities available at A. J. Institute of Medical Sciences, Mangalore for purpose of Recognition of MS(Orthopaedics) qualification against increased intake from 03 to 04 seats and renewal of recognition for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (11.07.2016) and decided to recommend to the Central Government that MS(Orthopaedics) qualification against increased intake from 03 to 04 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Committee also decided to recommend to the Central Government that the recognition of MS(Orthopaedics) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
