I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 10/10/2017 considered the Council Assessor's Report (29.06.2017) on the standard of examination and other teaching facilities for Renewal of Recognition of MD(Social & Preventive Medicine / Community Medicine) qualification for 04 seats at A. J. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (29.06.2017) and decided to recommend to the Central Government that MD(Social & Preventive Medicine / Community Medicine) qualification for 04 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
