Any Form of Ragging activities specified below are publishable as per law.

- Any conduct by any student or students whether by words spoken or written or by an act, which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in rowdy or in disciplined activities by any student or students, which causes or is likely to cause annoyyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- Asking any student to do any act, which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- Any act by a senior student that prevents, distrubs or disturbs the regular academic activity of any other student or a fresher.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person
- Any act or abuse by spoken words, emails, post public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- Any act that effects the mental health and self confidence of a fresher or any other student
- With or without an intent to derive a sadistic pleasure or showing of power, authority or superiority by a student over any fresher or any other student.
- To address seniors 'Sir'
- To perform mass drills
- To copy class notes, records etc
- To do menial job for the seniors
- To ask/answer vulgar questions

- To look at pornographic pictures to 'shock the freshers out of their innocence
- To force to drink alcohol. Scalding tea etc.
- To force to do acts with sexual overtones, including homosexual acts.
- To force to do acts which can lead to physical injury / mental torture or death:
- To strip, kiss etc.
- To do other obscenities
- To perform or enact sexual acts

Punishments: The following will be the punishments for those who are found guilty of participation in or abetment of ragging. The quantum of punishment shall, naturally, depend upon the nature and gravity of the offence as established by the Disciplinary Committee or the court of law.

- 1. Cancellation of admission
- 2. Suspension from attending classes
- 3. With holding/withdrawing scholarship / fellowship and other benefits
- Debarring from appearing in any test/examination or other evaluation process
- 5. Withholding results/
- 6 Debarring from representing the institution in any national or international, meet, tournament, youth festival etc.
- 7 Suspension / Expulsion from the hostel
- 8 Rustication from the institution for periods varying from 1 to 4 semesters
- 9. Expulsion from the institution and consequent debarring from admission to any other institution
- 10. Fine Rs. 1,00,000/-
- All parents & students have to furnish the affidavits each year, failing which admission/continuation of students will be suspended and hostaliers will be sent out.
- 12. Rigorious imprisonment as per Honorable Supreme Court or by a Court of Law
