

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 22/08/2017 considered the Council Assessor's Report (23.06.2017) on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesiology) qualification against increased intake from 05 to 08 seats at A. I. Institute of Medical Sciences, Mangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (23.06.2017) and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 05 to 08 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at A. J. Institute of Medical Sciences, Mangalore be recognized and included in the 1st Schedule to the LM.C. Act, 1956.
